# What we are looking for

Ukie is seeking candidates who reflect the breadth and diversity of the UK games industry. We welcome nominations from individuals at all stages of their careers and from all parts of the country.

### Ideal candidates will:

- Be currently working within a Ukie member company.
- Understand the challenges and opportunities facing the industry.
- Bring fresh perspectives and a collaborative mindset.
- Be committed to Ukie's mission and values.
- Take a sector-wide view, prioritising what is best for the industry as a whole.

Prior experience serving on a board is not required. We are looking for individuals with a strategic mindset, a willingness to engage, and the time to support the work of the organisation. Read the Board Member job description below to find out more.

### Role of a Board Member

As outlined in the Board Member job description in the Annex, Ukie Board Members are expected to:

- Provide strategic oversight and input on the organisation's activities and plans, including initiatives such as the Supercharged strategy.
- Ensure strong governance and financial oversight.
- Act as ambassadors for Ukie, representing the industry in public and stakeholder-facing roles.
- Participate in committees or working groups aligned with key organisational priorities.
- Champion diversity, innovation and sustainability across the sector.
- Contribute to performance reviews of the Board and senior leadership team.

Time commitment: Directors should expect to contribute approximately one to two hours per week, including attending bi-monthly board meetings (held in London or online), and participating in a one- or two-day annual strategy offsite, typically in January.

Term: Board members are elected for a two-year term and may serve up to three terms (a maximum of six years).

- Be employed by a Ukie member organisation full membership only.
- Complete the nomination form, including:
  - A short biography
  - o A 200-word statement
- Provide a headshot photo for use during the election process.

You can find more details on what should be included in the biography and statement in the Annex. We highly encourage you to read and review this before making your nomination.

All nominations must be submitted by 2<sup>nd</sup> September, 12pm.

All nominations, including headshots and statements will be available online for Ukie members to view and vote on.

# **Board Member job description**

### Overview

Ukie is the trade body for the UK's interactive entertainment industry. As a member of the board of Directors, you will play a crucial role in shaping the strategic direction of the organisation, ensuring it meets its mission to support, grow, and promote the UK games industry.

# Key Responsibilities

- Strategic Leadership: Provide strategic guidance and oversight to ensure Ukie's activities align with its mission, values, and goals. Participate in the development and approval of strategic plans, including the *Supercharged* strategy, which aims to power the future of the UK interactive entertainment industry.
- Governance: Contribute to the governance of the organisation by participating in board meetings and ensuring that UKIE operates within its legal and regulatory framework. While legal expertise is not required, a willingness to learn and understand governance principles is essential.
- Financial Oversight: Support the financial oversight of the organisation by reviewing budgets and financial plans. While financial literacy is not a requirement for the role, Directors should show a willingness to engage with financial matters. Training and support from your fellow board members can be provided as needed.
- Advocacy and Representation: Act as an ambassador for Ukie, representing the interests of the UK games industry to stakeholders, including government, media, and other industry bodies. Advocate for policies that support the growth and development of the industry.
- Stakeholder Engagement: Engage with Ukie members and other stakeholders to understand their needs and ensure their voices are heard in the organisation's decision-making processes.
- Committee Participation: Directors are invited to serve on one or more committees or task forces, contributing to specific areas of the organisation's work.
- **Performance Evaluation:** Participate in the evaluation of the board's performance and the performance of the Chief Executive Officer and Senior Management Team.

# **Qualifications**

- **Industry Experience:** Experience in the games or interactive entertainment industry, with an understanding of the sector's challenges and opportunities.
- Leadership Skills: People management experience is not required, but an ability to build consensus and drive strategic initiatives would be ideal.

• **Commitment:** A strong commitment to Ukie's mission and values, with the ability to dedicate the necessary time and effort to fulfil board responsibilities.

### Personal Attributes

- Integrity: Demonstrates high ethical standards and integrity in all actions.
- Collaboration: Works effectively with others, fostering a collaborative and inclusive board culture.
- **Visionary:** Possesses a forward-thinking mindset, with the ability to anticipate industry trends and challenges.
- **Communication:** Excellent communication skills, with the ability to articulate complex issues clearly and persuasively.

### **Time Commitment**

Board members should expect to attend meetings every other month (in person in London, or virtually), with a one or two day strategy offsite usually held in the South East of England, January. The time commitment is up to the board member, but Directors should expect to give approximately one to two hours per week.

### Term

Board members are elected for a term of two years, with the possibility of re-election for an additional two terms (up to a total of six years).

### Biography

Your biography should briefly outline your current role, your experience in the games industry, and any relevant achievements or areas of expertise.

# Personal Statement

Your personal statement should clearly outline your reasons for standing for election, the contribution you intend to make if elected, and how you will represent and support the Ukie membership. The statement must be no more than 200 words and will be published on the Ukie website for members to review during the voting process.
